
# General description and main objectives

Diverse food governance approaches necessitate a comprehensive assessment of **potential** synergies and gaps in food related policy instruments as well as a **better understanding of their impact and implementation in diverse local foodscapes / systems.** 

#### WP4 aims to:

- ✓ comparatively **analyse policy documents** to better understand different policies that support sustainable and organic food systems wp 4.1
- ✓ examine **stakeholders' involvement** in different local food systems to better understand barriers and drivers of change wp 4.2

## Diversity in policy interventions




- ✓ Document analysis
- ✓ Collect policy makers' views on a number of aspects concerning crucial contextual and policy factors, such as their perceptions on how existing public policies work and how European, national and regional legislations and policies are being translated locally.



Interviews (10-15) will be conducted following a set of common guidelines for all participating countries at different levels.

## Map food system actors and activities



- ✓ Analysis of existing ties among food organizations and other actors
   (consumers/consumer groups, political authorities etc.) to understand who holds a central position within the food system.
- ✓ Network analysis will focus at the local scale to observe how the structure of relationship is shaped by different contextual opportunities as well as actors' capacity to construct diverse value chains based on alternative flows of knowledge, information, and finance, as in the case of Alternative Food Networks (AFNs).

#### Methods

- Document analysis
- 15 in-depth interviews with keyinformants (policy-makers and practitioners) acting at different levels.

- Structured questionnaire designed to study both:
  - the characteristics of organizations
  - the relationships among them





Identify diversity in policy interventions to favour sustainable food production, distribution and consumption across the participating countries and at different levels (national, regional and local) – WP4.1

#### **GOAL**

❖ Map food system actors and activities in selected contexts to develop an in-depth understanding of how contextual factors and governance approaches contribute to shape food systems as well as to identify actors who play a key role for diversity and advancing transition towards more sustainable and integrated forms of production, distribution, and consumption – WP4.2



#### Outreach deliverables

- Conceptual map on major governmental policy interventions at different levels (from the international to the local level) **wp 4.1**
- Report on the diversity of policy interventions at different levels (national, regional and local) in the five countries wp 4.1
- Description and analysis of the composition and relational structures of actors involved in different food systems by means of social network analysis wp 4.2
- Network diagrams visualizing stakeholders' relationships wp 4.2
